

2019-20 access and participation plan monitoring

Provider impact report

This impact report summarises the progress made by University of York against targets, objectives and written commitments set out in its 2019-20 access and participation plan. This document is a summary of information submitted by the provider to the OfS. This document is a self-report by the provider only and does not indicate any OfS assessment of compliance.

1. Ambition and strategy

University of York's ambition and strategy as detailed in the 2019-20 access and participation plan:

Our overarching ambitions from our 19/20 Access and Participation Plan are summarised as:

- To remain an inclusive institution in accordance with York's original mission
- To contribute to the local, regional and national agenda for widening participation and social mobility.
- To maintain an appropriate balance between activities linked to the profile of our own students and their success and future opportunities, and those which raise aspiration and support attainment more widely through our collaborative and other work.
- To ensure that our students are supported to achieve their best throughout their studies and beyond
- To continue to work towards stretching targets for our main areas of activity
- To develop further our understanding of our own position and the progress of our students through the access, success and progression life-cycle in order to identify areas for targeted action.

The strategic approach to our 19/20 Access and Participation Plan was to ensure that all activity was informed by the following principles:

- Evidence-based, so that we ensure that interventions have clear aims and are addressing genuine areas of concern;
- Targeted, taking into account a variety of indicators so that we directly reach those who can benefit most from out interventions;
- Sustained, so that measures and investment are given appropriate time to show a return
- Monitored and evaluated, so that activity can be adjusted and developed depending on our assessments of impact;
- Collaborative where appropriate and beneficial, so that the reach of our activities is extended as far as possible.

Annex A: Commentary on progress against targets

University of York's commentary where progress against targets was less than expected.

Target reference number: T16a_04

How have you met the commitments in your plan related to this target?

Yes - Our Open Door and Disability Services Team have continued to offer support for our students, both moving to a remote service from March 2020 as a result of the Covid-19 pandemic and associated restrictions.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

Our Disability Services team has worked closely with Admissions colleagues to ensure that all students who have declared a disability are aware of the services offered for disabled students and how to get in touch. The Disability Services team have also attended all Open Day events, as well as Departmental Visit Days, to provide information about our services to offer-holders and prospective students and to deliver talks to encourage students to disclose disabilities. We have also added a video to the University's Disability webpages to encourage disclosure, as well as screen displays around campus to encourage students to contact Disability Services. Our teams also works closely with our Disabled Students' Network who work directly with our students to encourage disclosure.

How have you met the commitments in your plan related to this target?

No - due to the hands-on, practical nature of Excellence Hub activity the majority of events had to be cancelled from March 2020 onwards as a result of the Covid-19 pandemic.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

Before the Covid-19 restrictions began, we delivered 29 collaborative events, engaging 781 students from across 71 schools. Due to Covid-19 restrictions, many of our Excellence Hub events were cancelled. We continued to support schools and colleges through a monthly newsletter featuring online provision delivered by individual partner institutions. At York, we developed two online hubs of provision for pre-16 and post-16 pupils which engaged over 1600 students from schools and colleges across the region.

T16a_01	This target now reflects POLAR4 from the academic year 18/19 onwards in line with the reporting of HESA T1a. In the last year of POLAR3 we had comfortably exceeded our target.
T16a_02	We are performing well above this target which is reflected in our 20/21 - 24/25 APP having more specific ethincity targets.
T16a_03	We are currently ahead of expected progress against this target. Both our young and mature non-continuation rates remain below the benchmark published in HESA PI Table T3. As such this target has not been carried forward to our 20/21 - 24/25 APP.
T16a_04	For the year in question we are 1.3% behind our target however it should be noted that in the subsequent years we have seen a significant rise in declerations with figures of 15.7% in 19/20 and 16.5% in 2021. As such we have not carried this target forward to our 20/21 - 24/25 APP.

T16b_03	The RO collaborative target is reframed within 2020 – 2025 APPs to ensure a robust reporting of the impact RO is having on access to research-intensive universities (RIUs). For 2020 – 2025 APPs RO will demonstrate maximum ambition for RO students and track two years of access to RIUs using HEAT data, rather than UCAS end of cycle data. UCAS data has been used for all RO collaborative targets prior to 2020 – 2021. UCAS data reported here is for the 2020 UCAS cycle. Data used for reporting against the first milestone in 2020 – 2025 APPs will include those who accessed HE in the 2020 UCAS cycle but will include students from the 2021 UCAS cycle and will be confirmed entrants via HESA.

T16b_08	In 18/19 we worked with 80 school students, the figure for 19/20 was reduced (60 students) as we worked with one less school and focused on refining the programme rather than expanding. The 19/20 programme started but was cut short by the Covid-19 pandemic. We recruited tutors for 20/21 but were unable to go ahead with tutoring due to the third national lockdown.
