DIRECTOR'S REPORT 2018-19

Founded only in 2005, CREMS has serious claim to be considered as the leading centre for interdisciplinary research in Renaissance and Early Modern studies in the English-speaking world. Together with the CMS, CECS and CModS, the activities of these interdisciplinary centres are essential to the international high standing and underpin the excellent REF performance of York's Faculty of the Arts and Humanities.

CREMS has inspired several imitators in UK HE (e.g. Birmingham and Sheffield; while Kent and Durham have centres of Medieval and Early Modern studies) but no genuine rivals. Drawing on the expertise and energy of its currently 44 affilitated faculty from eight academic departments and 50 affiliated students registered for Ph.D, CREMS offers a vibrant and supportive environment for research into the history and culture of the early modern world between c.1450 and c.1700. In addition, it attracts to its events and activities postgraduate students who are enrolled on MA's from the Centre's affiliated departments as well as academics from HEIs throughout not only the North of England. Average attendance at seminars 2018/19 was ca.18, with considerably more at guest lectures, such as the prestigious annual event, co-sponsored with the department of English and Related Literature and named in honour of C.A. Patrides (1930-86), founding professor of Renaissance Literature here at York, which this year was given by Jessica Wolfe University of North Carolina at Chapel Hill.

It is a reflection of CREMS's continued standing as a promotor and facilitator of worldclass research that its affiliate members play leading roles in the following, ongoing major projects (with their associated publications): the Leverhulme Trust Research Leadership award: Rethinking Civil Society: history, theory, critique (£828,772), PI Tim Stanton (Politics), begun in 2017; the AHRC projects, Remembering the Reformation, CI Brian Cummings (English) (£325,963), begun in 2016 and Renaissance Encyclopaedism: Oxford works of Sir Thomas Browne (2013-18) which has been led by Kevin Killeen (English). Emilie Murphy (History) won an AHRC grant as CI of £49.159.69 (incl. FEC) for Soundscapes in the Early Modern World, the first event of which was a workshop hosted in the HRC with the support of CREMS on 25-26 January 2019. This was followed by two further workshops: 'The Architecture of the Soundscape' (22-23 April 2019) held at the University of British Columbia and 'Archiving the Soundscape' held at the Wellcome Collection (19-20 September 2019). Other future events include a second workshop in the HRC – 'Sound Affects' (23-24 April 2020) and a major international conference to be held in Liverpool at John Moores University (14-16 July 2020). In Spring 2019 we also received news that from October 2019 York will host the new Levehulme Centre for Anthropocene Biodiversity, in a grant worth almost £10 million over the next decade, one of whose two associate directors is CREMS member – and former director – Mark Jenner (History) who will be supervising several postdoctoral fellows and at least one graduate studentship (on 'Gardening as a force in ecological history') beginning later this year (2020). Other recent

successes include: Dee Dyas (Christianity & Culture) £80,000 (AHRC) 12 months from 1 September 2019 for the project: 'Engaging with place: managing space' and John Cooper (History) £4,750 (AHRC) 12 months from 1 September 2019 for 'Henry VIII on Tour' as PI and, most recently, as CI - £123,500 (AHRC) for three years from 1 June 2020 (with Damian Murphy, Electronics) for 'The Past Has Ears'.

In this most recent reporting period (September 2018-September 2019), CREMS hosted (or co-hosted) twelve visiting speakers (incl. two from the USA and one each from Germany, Italy and China) and several organised workshops or symposia; one of which 'Shakespeare & Co: from the page and onto the stage' (18 May) was organised by one of our postgraduates, Andrea Paquin in conjunction with the York International Shakespeare Festival and included the public lecture by Ben Crystal: 'Speaking the Bright and Beautiful English of Shakespeare'. This was one of two conferences organised by postgraduates in 2018-19. The other one was: *Art as Commodities/Commodities as Art* (14-15 June) co-organised by Adam Sammut (History of Art) with WRoCAH postgraduate colleagues from Leeds and Sheffield Other York symposia supported by CREMS included the Thomas Browne Seminar (31 May) *Thinking with Mysticism* (keynote speaker: Dr Sarah Apetrei (Oxford), organised by Kevin Killeen (English) and *Recognition and Respect: from Hobbes to Honneth*, 11-12 July 2019; organisers: Tim Stuart-Buttle (York) & Heikki Haara (University of Helsinki)

Among the York-based events, two of the guest speakers plus one of the symposia – were organised by the very active CREMS postgraduate forum, known as the Cabinet of Curiosities. This is entirely run by postgraduates for postgraduates (led by the dynamic duo of Mathilde 'Tilly' Zeeman and Amy Creighton) and is financially supported by CREMS. It includes not only doctoral students but also those taking the various relevant MA programmes run by the affiliated departments. This reflects CREMS's determination to involve colleagues from all career stages also in the organization of events and selection of speakers. Moreover, students are encouraged to suggest speakers for the main seminar programme. In March this year Tilly Zeeman, former co-convenor of the Cabinet of Curiosities is putting on the conference: 'Courage, Language, Discretion and Learning': Lancelot Andrews and early modern Religious Culture. It has been supported by CREMS as well as by the Society of Renaissance Studies.
