INTRODUCTION

Who We Are and What We Do

The Centre for Renaissance & Early Modern Studies (CREMS) was launched in 2005 as a forum for interdisciplinary research and teaching on 15th-, 16th- and 17th-century Britain, Europe and the wider world.

CREMS is, we believe, the largest centre of its kind in the UK, bringing together more than 30 members of staff and their postgraduate students from eight departments across the Arts, Humanities and Social Sciences. BBC History Magazine has described us as one of the UK's two top places to study the Renaissance period, and we are now known worldwide for our leading research on the interface between the history of the book, the history of religion and the history of ideas. Other clusters of expertise include space, landscape and the environment, violence and crime, editing and performance, and the court cultures of England, Italy, Holland and France.

We run a full programme of international conferences, study days, research seminars, public lectures, reading groups and film nights. We have developed an interdisciplinary MA and awarded postdoctoral fellowships and postgraduate studentships; and we have fostered a number of collaborative research projects involving staff from multiple departments, whilst also building links with other scholars and public institutions across the UK and abroad. Members of the centre have recently been awarded major grants from the AHRC, fellowships from the British Academy and Leverhulme Trust, and visiting professorships at leading universities around the world. We have been working closely with the Borthwick Institute for Archives (a purpose-built facility next to the University Library) and York Minster Library (the largest Cathedral library in Britain) and have begun to forge links with the university's new Department of Theatre, Film and Television, the Institute for the Public Understanding of the Past, cultural organizations in and around York, and with potential partners across the UK, Europe and North America.

The **Director** of CREMS is Bill Sherman (English). The **Steering Group** is convened by the Coordinator of Arts and Humanities (John Local) and consists of the Heads of Department of the three parent departments, History (Bill Sheils), English (David Attwell) and History of Art (Mark Hallett). Each participating department has a representative on the **Advisory Group**: Mark Jenner (History), Helen Smith (English), Amanda Lillie (History of Art), Jon Parkin (Politics), Jo Wainright (Music), Tom Stoneham (Philosophy), Kate Giles (Archaeology) and Mike Cordner (TFTV). There are **Postgraduate Reps** for both the PhD and the MA. Our **Administrator** is Sally Kingsley (sk23@york.ac.uk; +44-(0)1904-328128).

Highlights

- CREMS moved into its new office in the Humanities Research Centre, on the
 1st floor of an award-winning lakeside building at the heart of the Heslington
 campus. Named after Berrick Saul (Vice-Chancellor 1979-93) it provides
 state-of-the-art lecture and seminar rooms, offices for interdisciplinary
 centres and research projects, and study and social space for our
 postgraduates.
- Helen Pierce (our inaugural postdoctoral fellow) crowned her achievements at CREMS by publishing her monograph, *Unseemly Pictures: Graphic Satire* and Politics in Early Modern England, in the prestigious series produced by Yale for the Paul Mellon Centre for Studies of British Art.
- Varsha Panjwani finished her PhD on dramatic collaboration (with the support of a CREMS PhD Studentship), was awarded a short-term fellowship at the Folger Shakespeare Library in Washington DC, and appointed to a lectureship in our new department of Theatre, Film & Television.
- Amy Pitts finished her MA (with the support of a CREMS MA Studentship) and is now the Welcome Team Leader at Kensington Palace in London.
- MA Distinctions were awarded to Emilie Murphy and Tom Palmer.
- Prison Writings in Early Modern England, an essay collection edited by Professors Bill Sherman (English) and Bill Sheils (History), received the inaugural Voyager Award at the 2009 MLA convention. The collection began its life as a CREMS conference in 2007 and was published as the June 2009 issue of the Huntington Library Quarterly (http://caliber.ucpress.net/toc/hlg/72/2). The Voyager Award is given by the
 - (http://caliber.ucpress.net/toc/hlq/72/2). The Voyager Award is given by the Council of Editors of Learned Journals (CELJ) to the issue with the best coverage of the period 1500-1800. From the judges' citation: 'Prison Writings in Early Modern England reflects on a neglected literary genre devoted to marginal, often stigmatized experience, organizing and focusing for the reader a dazzling array of literary and documentary texts of the period, and situating them in the cultural politics and poetics in which they participated more, and much more eloquently than we knew. The articles in this issue cover the whole period from More to Bunyan, capture the experience of both men and women, spies and dissenters and inventors, and most importantly allow those writing about incarceration to speak for themselves across the centuries in ways that humanize the prisoner and query the social structures to which they were subject. Beautifully conceived and executed, Prison Writings in Early Modern England is a profoundly informative and humane work.'
- We co-sponsored the Annual Patrides Lecture (Dept of English): this lecture series was established to honour the distinguished Renaissance scholar CA Patrides, who taught at York from 1963 to 1981, and past speakers form a veritable Who's Who of Renaissance Studies. This year's lecture was delivered by Anthony Grafton (Princeton) on 'Jewish Books and Christian Readers: Another Renaissance.'







- We launched an annual public seminar at the National Centre for Early Music, to combine research and performance on some aspect of the early modern musical world. Our first event featured Chris Marsh (Belfast) on 'Music and the People in Early Modern England,' with musical examples performed on the fiddle.
- We successfully applied for a 3-year AHRC Collaborative Doctoral Award on the early history of the Castle Howard library and its influence on the creation of the estate, and Hannah Moor takes up the position in October 2009. Hannah was in the first cohort of the CREMS MA and comes back to York after two years working at the Bodleian Library and Ashmolean Museum.
- Dr. Piers Brown won a Canadian-funded SSHRC two-year postdoctoral award and joins us in October 2009 to work on John Donne's library and reading practices.
- We co-hosted Professor Helen Hills's AHRC Research Network on 'Exoticizing Vesuvius (Topography and Culture in Neapolitan History, c.1500-present),' now being developed as an international network/society for Neapolitan Studies.
- We co-hosted 'Shakespeare Configured,' a 2-day international conference looking at new approaches to the textual and visual morphology of Shakespeare from the earliest quartos to Manga comics. The event was cosponsored with the English Dept at the University of Bergen and there will be a follow-up conference in October 2010 at the CNRS in Montpellier, with the aim of producing a book, developing electronic resources and building a postgraduate research network.

Looking Ahead

- We have an exciting programme of international conferences in the works. In July 2010 we will host the biennial international conference of the Society for Renaissance Studies (http://www.york.ac.uk/crems/srsconference). Over three days, conference delegates from nearly 20 countries will present more than 200 papers in some 50 panels and, in addition to plenary lectures by Quentin Skinner, Iain Fenlon and Penelope Gouk, there will be workshops on publishing and research funding and tours of historic buildings around the city. In September 2010 Cordula Van Wyhe will run a conference on Rubens and the Human Body. And in July 2011 Kevin Killeen will mount a major international conference to mark the 400th anniversary of the King James Bible.
- We are developing a strong cluster of people and projects related to the history of libraries and archives--building on the arrival of Hannah Moor and Piers Brown and taking advantage of our contacts with the Borthwick Institute, Minster Library, Yorkshire Country House Libraries Project and other partners in the UK and abroad. Kevin Killeen (English) is part of a major research application devoted to Thomas Browne which would involve a mini-project on reconstructing Browne's library; Bill Sherman and Bill Sheils will soon be submitting a large-scale research grant application on

'Archbishops and their Books: Archiepiscopal Libraries in Post-Reformation England'; and CREMS staff and students have begun to meet as a 'Library History Working Group' to discuss key readings and share work in progress. On 18 March 2010 we will host the annual Thomas Browne Seminar and the topic this year is 'Early Modern Libraries.'

We look forward to building on our accomplishments and to expanding our range of activities as we work to enhance the knowledge and appreciation of a crucial period in British, European and Global history. We welcome inquiries from potential students, partners or donors about any of the activities described above and below.
