Scottish figures exclude provision for NLF repayments, expenditure on Scottish Homes' properties and 'GRO' grants to private developers. 'Housing corporations' include Housing for Wales (Tai Cymru), and Communities Scotland; these are now part of the respective administrations of the Welsh Assembly Government and the Scottish Government.

The Homes and Communities Agency took over from the Housing Corporation during 2008/09. The 2008/09 figures for England relate solely to the national Affordable Housing Programme.
