IC7/034 MATTERS ARISING

IC/034.1 Window washing [IC7/028.3]

CA not present so awaiting outcome

IC7/034.2 IIU link [IC7/030.2]

IC7/034.3 Annual pressure testing of autoclaves [IC7/030.3]

Labels not ready yet.

IC7/034.4 Recent glasshouse incident [IC7/030.4]

DC has confirmation from John Street and Tom Fleming that a meeting will be arranged to discuss who takes responsibility for contractors on site.

IC7/034.5 Visitors to Teaching [IC7/031.1]

NC reported that she was now being informed when contractors etc are on site.

IC7/034.6 Paper towels v hand dryer [IC7/032]

Information is currently available from EAUC members. DC is collating this and will pass it on to the new energy manager.

IC7/034.7 Estates questionnaire [IC7/033.3]

DC thanked those who had contributed to this and comments had now been sent to Estates Services.

IC7/035 SAFETY

IC7/035.1 Local exhaust ventilation testing

DN reported that a recent safety inspection of the Workshops area highlighted the fact that LEV testing of their equipment is still outstanding. PC stated that there is an agreement in place with Estates Services and that the contractors on site testing fume hoods should be carrying this out (with cross-costing to Estates Services). DC requested that DN contacts Len Brindley for confirmation that this will take place.

IC7/035.2 Dangerous fire exit route

DN commented that poor drainage in the Workshop yard meant that algae could be a slip hazard. PC stated that Gordon Eastham has been to inspect the site and has agreed that the gulley will be cleared and the yard will be pressure washed.

IC7/035.3 Ventilation grilles

DN reported that a complaint had been received about the ventilation grilles in the YSBL lab area. These should be cleaned regularly and previously PC has asked the

cleaning supervisor. DN to contact DH for advice.

IC7/035.4 Smell on E0

DN commented that he had been approached by various people who were complaining about the smell on E0. This has been caused by stagnant water and pigeon debris in the lift shaft and is not helped by the blocked louvres at the top of the shaft. Estates Services are currently dealing with this.

DN had had a complaint about splashed water round dispensers. A reminder has been sent to relevant staff but these areas should also be considered in the ongoing assessment of hazardous sites.

IC7/037 ENVIRONMENTAL PERFORMANCE

IC7/037.1 Atrium lights

DC reported that the Atrium lights were now on a photocell with the Lobby areas on a separate circuit. The photocell can be overridden if the lights need to be switched on for special events. Reception to label switches. The lights along A corridor should also have been done but there was some doubt so NC to monitor.

IC7/037.2 Metering project

DC reported that the electrical contractors Rothwells will be on site this weekend to change the metering systems to allow improved meter readings. It is hoped that the Department will have access to these readings in the future.
