22-year-old student leader and activist Siphiwo Mtimkulu and his friend Topsy Madaka were shot and burned in 1982 by the apartheid era Security Police in South Africa. 18.15 hs. Horacio Verbitsky: “Forced disappearances in Argentina during the last dictatorship (1976-1983)”

Horacio Verbitsky (born 1942 in Buenos Aires) is a prominent Argentinian investigative journalist and author. He is a political columnist with the Argentine newspaper *Página/12*, a member of Human Rights Watch/Americas and of the International Consortium of Investigative Journalists. He was also a member of the Board of the Fundación Nuevo Periodismo Iberoamericano for 10 years chaired by Gabriel García Márquez.

Since 2000 he has served as Director over the Argentine human rights organization the Centre for Legal and Social Studies (CELS). In March 2001 a joint case brought by CELS and the Grandmothers of Plaza de Mayo succeeded in overturning the pardon laws relating to the past dictatorship. This ruling was affirmed by the Supreme Court in 2005 and has subsequently enabled 262 convictions for gross human rights violations from that period.

His 20 books on political, social, economic, military, ecclesiastical and human rights subjects have had a strong impact in the public agenda. "Civil society and the military. Secret memories of the transition" is about the trial of former Military Junta leaders and Raúl Alfonsín's Pardon Act; "The Flight. Confessions of a dirty-warrior" contains the chilling confession of a former Argentine Navy officer who threw 30 living people out of naval planes into the ocean during the so-called dirty-war. His recent books include a political history of the Catholic Church in Argentina. Verbitsky was awarded the Prize of the Latin American Studies Association for "best long term journalistic coverage in Latin America", for "his absolutely essential role in the

investigation of human rights violations under the military regime and of corruption under constitutional governments”.

Sri Lanka: Disappearance as a counterinsurgency tool

Sri Lanka's government officials have exhibited a consistent lack of political will to punish perpetrators of serious human rights violations. It has maintained its reliance on special security legislation to circumvent normal laws that might protect against arbitrary arrest and detention and thus prevent enforced disappearances and also failed to adopt appropriate legislation on enforced disappearances. This lack of political will coupled with a culture of impunity has allowed for tens of thousands of disappearance cases to go unresolved in the country.
