As this programme has a vocational leaning, it also has more specific educational aims:</p> <ul style="list-style-type: none"> • To explore social enterprise principles, problems and issues (mainly within the context of the UK environment). • To provide an opportunity for practical, project-based learning which requires planning, creative thought and problem solving • To enable participants to make informed decisions about their engagement with social business, community and volunteer projects. • To develop an awareness of the new and changing landscape of Civil Society • To enhance the ability to work as a team member in social projects • To encourage students to recognise and react to ethical issues surrounding social business activity • To develop the ability to lead and motivate others in the pursuit of community goals • To encourage students to seek project sustainability at an early stage, avoiding reliance on grant support • To provide a grounding in basic business practice and risk awareness as applicable in social and community project activity • To develop students' basic skills in creating and managing their own social and community projects and to work as effective team members in such enterprises. • To heighten students' awareness of ethical aspects in business activity. • To add to students' abilities to work as team members and leaders • To enable students to perceive their own project in the overall context of social and community enterprise • To allow students to experiment with project design in a practical setting using their peers as a resource for feedback and direction • To provide an arena for accessible and inclusive discussion about social and community projects • To support the development of students' projects through to launch and beyond by offering continued access and advice
