Within each module, participants can focus on different learner age groups (1-8)</li> <li>• The on-line and self-study materials are interactive and students are encouraged to evaluate arguments, critically engage with theory and practice in their chosen field, and undertake problem solving activities (1-8)</li> <li>• Data collection and analysis are developed through the research methodology modules and through the production of an independent study (1-8)</li> </ul> <p>Types/methods of assessment (relating to numbered outcomes)</p> <ul style="list-style-type: none"> <li>• Knowledge and understanding is assessed primarily through course work assignments (1-7)</li> <li>• An Action Research Project is used to assess the depth of knowledge and understanding of research processes and procedures students have acquired throughout their studies and to assess their ability to conduct an independent study (1-8)</li> </ul>

Students have the opportunity to further develop work and study skills through researching and producing assignments and an independent study. The entire course is an exercise in time management. Students are required to set objectives, determine priorities, schedule their workload and meet deadlines (1-5)</li> </ul>
