Skills of critical evaluation and analysis are further enhanced though directed tasks. Pinnacle trainees in Drama and History and Red Kite trainees following the English, History, Geography, Business Studies, Drama and Computer Science routes engage in workshops and seminars with a subject specific focus in School. (1 – 12) Trainees undertake a one week Primary Placement, and a one week Red Kite placement. 4 Days per week in Autumn term and beginning of spring term with 2 four week blocks. Second Placement (10 weeks).
