<p><b>Assessment Guidance</b></p> <p><u>Assessment Title</u>  Dissertation</p> <p><u>Assessment Guidance</u>  The dissertation is an independent, systematic literature review that addresses a clear question relevant to nursing practice. It assesses your ability to identify, appraise, analyse and synthesise evidence, and to consider the implications for practice, policy and research. These guidelines should be read alongside the module Dissertation Guidance and the Level 7 marking criteria.</p> <p><u>Required Structure:</u></p> <p><u>Your dissertation must follow the sequence set out in the module Dissertation Guidance (available on VLE):</u></p> <ul style="list-style-type: none"> <li>• Title page (exam number only)</li> <li>• Abstract (up to 300 words)</li> <li>• Contents page</li> <li>• Lists of tables and figures (if used)</li> <li>• List of abbreviations (if used)</li> <li>• Acknowledgements (no names)</li> <li>• <b>Chapter 1. Introduction and background/rationale</b>  Sets out the context, relevance to nursing practice, rationale for the review, and the review question.</li> <li>• <b>Chapter 2. Methodology and methods</b>  Includes review type and justification (e.g. scoping review, integrative review), search strategy, inclusion and exclusion criteria, data extraction, critical appraisal, and approach to analysis and synthesis</li> <li>• <b>Chapter 3. Results</b>  Includes PRISMA flow diagram, summary of included studies, synthesis of findings</li> <li>• <b>Chapter 4. Discussion</b>  Interpret main findings of review in relation to relevant policy and literature, noting strengths and</li> </ul>			

limitations, implications for nursing practice, and recommendations for research

- **Chapter 5. Conclusion**

Provides a concise statement of what the review shows and how it answers the review question

- Appendices (including anonymised proposal, search strategies, data extraction tools etc)
