Assessment Guidance

Formative assessment

Part One: Midpoint interview with Practice Assessor during week nine of Professional Internship.
 Part Two: You are required to give a 5-10-min presentation outlining the ideas you are developing for your reflective essay. You will receive supportive feedback from your peers and the facilitator.

Summative assessment

To achieve the outcomes for Professional Internship 1, the student will demonstrate a range of essential skills and competencies as identified by the NMC (2010) and Essence of Care, Department of Health (2010) for Stage 3.

There are three parts to this assignment.

Part One is the successful completion of the Electronic Ongoing Assessment Record Stage 3B. Practice will be assessed as a pass/fail by your Practice Assessor using the criteria provided within the documentation.

Part Two is a 1,500 word reflection on the organisational aspects of care, particularly focusing on ONE of the following essential competencies:

- Exploring solutions and ideas with others to enhance care
- Challenging the practice of self and others across the multi-professional team
- Working inter-professionally as a means of achieving the optimum outcomes for people and ensuring the safety of themselves and others
- Taking responsibility for delegating care to others, including the preparation, support and supervision of others to whom care has been delegated.
- Negotiating with others to balance competing and conflicting priorities

The notes taken in your EOAR using *Element 1 – What?* of Driscoll's (2001) model of reflection will form the basis for your essay. To reflect upon the experience you have noted you need to follow the next two elements of Driscoll and use the following questions to assist you to understand the context of that element of practice and how you might modify future practice in relation to the specific aims of the module.

Element 2 – So What?

What were you feeling at the time?

What are you feeling now?

What were the effects of what you did?

What good emerged from the situation?

What troubles you, if anything?

What have I noticed about my behaviour in practice by taking a more measured look at it?

Element 3 – Now What?

What are the implications for me in practice?

What difference does it make if I do nothing?

Where can I get more information to help me face a similar situation again?

How can I modify my practice if a similar situation was to happen again?

Who can help me 'modify' my practice?

How will I notice that I am different in practice?

What is the main learning I can take from reflecting on my practice this way?
