#### **Assessment Guidance**

You, your Practice Assessor and Academic Assessor should meet to evaluate your achievement of the required summative outcomes.

To pass the placement you must have met each of the following criteria by the end of the scheduled placement or by the end of the automatic extension period of 4 weeks through a summative Action Plan:

- 1. A summatively assessed Episode of Care with your Practice Assessor
- 2. Professional Values outcomes
- 3. Verification of all Stage-related Proficiencies
- 4. Achievement and verification of medicines management outcomes
- 5. Practice Assessor and Academic Assessor verification of your Ongoing Achievement Record (OAR)
- 6. You should aim to have completed all hours assigned to Stage One (hours for KANP1 & KANP2) by the end of practice placement 2. A stage deficit of more than 150 hours will require you to undertake the retrieval placement whilst on a summative action plan to reduce the hours deficit below 150 hours. The Department of Health Sciences strongly advises you to have a zero-hour deficit at the end of each stage.
- 7. The Electronic-Ongoing Achievement Record (E-OAR) must be completed in full and verified by you and your Practice Assessor.

## **Formative support**

To assist you meet the summative requirements you should arrange:

- A Formative Episode of Care, with opportunity for feedback on your progress.
- A documented mid-point interview in PebblePad with feedback on your performance so far; commenting on areas of strength and areas for improvement. A review of proficiencies should also take place.
- A review of your performance against the NMC Professional Values.
- If a concern is raised, you will be commenced on a supportive formative action plan this will require input from you Academic Assessor, your Practice Assessor, and the Practice Learning Link Team (PLL).
