<b>Assessment Guidance</b> <b>Part 1 – OAR Completion</b> You and your Practice Assessor should meet to evaluate your achievement of the required summative outcomes.  To pass the placement you must have met each of the following criteria by the end of the scheduled placement or by the end of the automatic extension period of 4 weeks through a summative Action Plan:  <ol style="list-style-type: none"> <li>1. A summatively assessed Episode of Care with your Practice Assessor</li> <li>2. Professional Values outcomes</li> <li>3. Verification of having met the Stage Proficiencies</li> <li>4. Practice Assessor verification of your record of achievement</li> <li>5. Medicines management outcomes</li> <li>6. Ensuring that your E-OAR will be completed by the submission date on the assessment schedule.</li> </ol>			
<b>Part 2 – Closed Exam</b> You will sit a closed online exam assessing your competence in medicines management numeracy using the safeMedicate platform.  This is part of the health numeracy assessment required by the NMC (2018 – <a href="#">Part 3: Standards for pre-registration nursing programmes</a> , section 4: Supervision and assessment, sub-section 4.6).  You are required to complete the unseen medicines calculation assessment and obtain a score of 100% in order to pass.  You should check your access to, and be familiar with, the safeMedicate platform in advance of the exam.			
<b>Formative support</b> <b>Part 1 – OAR Completion</b> To assist you meet the summative requirements you should arrange: <ul style="list-style-type: none"> <li>• A Formative Episode of Care with opportunity for feedback on your progress</li> </ul>			

- A mid-point interview with feedback on your progress. This should include assessment against professional values
- The use of a formative Action Plan where concerns have been identified in relation to meeting the summative requirements

**Part 2 – Exam through safeMedicate**

To assist you in developing your knowledge, in safe medicines management you will use safeMedicate to develop medicines calculations skills and undertake formative assessments during the programme.
