## UOY/F/APB Academic Planning Board, 1960 – 1973

Appointed by the York University Promotion Committee (UOY/F/YUPC) in September 1960 on the recommendation of the University Grants Committee, the Board's terms of reference were: to consider arrangements for the maintenance of academic standards and the awarding of degrees; to consider the range of subjects offered and length and character of undergraduate courses; to prepare a petition for a royal charter for a university and to establish its governing body; and to select the first Vice-Chancellor.

The chairman of the Academic Planning Board was the Rt. Hon. Lord Robbins (Professor of Economics at the University of London), and the Secretary, John West-Taylor (Secretary, York Academic Trust). Other members were Professor W. Mansfield Cooper (Vice-Chancellor, Manchester University), Sir Francis Hill (President of Nottingham University Council and a solicitor), Lady Ogilvie (Principal of St Anne's College, Oxford), Mr H. Oldman (Chief Education Officer, York), Professor J.G. Wilson (Professor of Physics, Leeds University) and Sir William Hodge (Master of Pembroke College, Cambridge).

Among the subjects considered by the Board were the general character of the University, the collegiate system, proposed subjects of study, staff appointments, and the University's governance.

Following the formal incorporation of the University on 1 October 1963, the Board was succeeded by the University's Academic Advisory Committee (UOY/M/AA). Papers relating to the University's early academic development and the establishment of departments and courses can also be found in the Vice-Chancellor's correspondence and subject files (UOY/VC1).
