UOY/F/YUPC York University Promotion Committee, 1956 – 1966, 1971

In 1947, a York deputation met with the University Grants Committee, the government body then responsible for funding higher education institutions, concerning proposals to establish a university in the city. The meeting marked a renewed attempt (the first dated from the seventeenth century) to gain such an establishment. Sponsored principally by the York Civic Trust, and its chairman, John Bowes Morrell, an Academic Development Committee of the Civic Trust was formed in order to establish further York's academic credentials. In consequence, in 1953 the Committee founded the Borthwick Institute of Historical Research (UOY/BI) and the Institute of Advanced Architectural Studies (UOY/IAAS) in order to support the application for a university. In March 1956 the Civic Trust's academic development committee was officially incorporated, becoming the York Academic Trust (UOY/F/YAT), an independently constituted charitable institution.

In September 1958 the University Grants Committee published a report *University Development* 1952-1957, which predicted a substantial increase in the national demand for university places. York Academic Trust approached York City Council and, in October 1959, it was decided that a widely representative sponsoring body be set up to make a new approach to the UGC for the establishment of a University of York.

The York University Promotion Committee was established on 19 November 1959 to prepare and present a case for a University of York and, subsequently, to plan the University and implement the initial stages of its establishment. This included providing properties and accommodation for the University and making the early appointments. Chaired by the Archbishop of York, the first meeting of the Promotion Committee was held on 25 November 1959. The Committee was later set on a firmer legal basis in March 1961 when, by means of a 'Declaration of Trust', it was empowered to hold and administer funds and property on behalf of the University. At the same time the Committee was more formally constituted, with regulations for its administration being incorporated in the Deed.

Most of the initial University appointments were made in 1962, by which date a temporary administrative base had been established in the King's Manor. At the close of 1962 three professors were already in residence and the Librarian had taken up his post

The Promotion Committee included representatives of the City of York, the three County authorities, the York Academic Trust, the C. and J.B. Morrell Trust, the Joseph Rowntree Memorial Trust and the Joseph Rowntree Social Service Trust. It was chaired by the Archbishop of York, Dr Donald Coggan, and its members included Alderman Ralph Butterfield; Lloyd Owen, chairman of Rowntrees; John West-Taylor (Secretary); Dr J.B. Morrell; the Very Rev. E. Milner-White, Dean of York; and Sir John Dunnington-Jefferson.

In 1960 the Committee appointed an Academic Planning Board (UOY/F/APB).

Sub-committees existed in respect of the Building and Development Appeal (launched May 1962), the Coat of Arms, Staff Housing, King's Manor, Estates and Buildings, Academic Robes, Catering Finance, Salaries, Finance.

The last meeting of the Promotion Committee was held on 20 November 1963. Following its closure the Trustees transferred to the University all the properties held by the Committee. The University Council (UOY/M/C) succeeded the Promotions Committee and assumed overall responsibility for the administration and management of the University's property and affairs.
